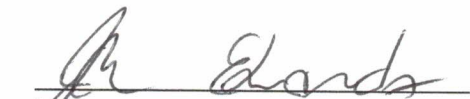

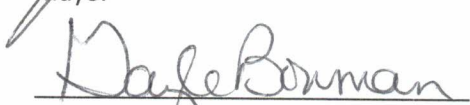

Adjournment:

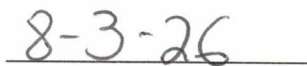

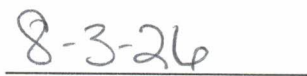
