Ordinance 2025-01 Budget Amendment

Ordinance amending the 2024-2025 budget to account for the purchase of the park property. Mayor Edwards made a motioned to approve, Seconded by Vice Mayor Pettus. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. 2nd Reading: 3-0.

Adams Fire Donation: Mayor Edwards and Commissioners presented Chief Donovan Tucker with a check in the amount of \$10,500. This check represented the 2% expense budget donation from the City of Cedar Hill and the Go Fund Fundraiser.

Tourism Grant: Mayor Edwards presented a proposed purchase of two stainless steel prep tables for the concession stand which would complete the Tourism Grant spending. Mayor Edwards made a motioned to approve, Seconded by Commissioner Kirby. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. Approved 3-0.

Ordinance 2025-04: Rezoning Request from C3 to R4 on Jackson Street: Mayor Edwards presented a rezoning request for 1.10 acres from C3(Commercial\_ to R4(Low-Density Residential). Mayor Edwards made a motioned to approve, Seconded by Commissioner Kirby. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. Approved 1<sup>st</sup> Reading 3-0.

Street Mowing: The commissioners all agreed to street mowing.

School Outreach: *Donuts for Teachers & End of Year Pizza for Schools* Vice Mayor Pettus presented the annual donation to schools for teacher appreciation and the end-of-year pizza donations for the whole school. This year Jo Byrns Middle & High School are allowing the City to dish out pizza to the school in addition to the Elementary School. Mayor Edwards made a motioned to approve, Seconded by Commissioner Kirby. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. Approved 3-0.

Ordinance 2025-05 Fiscal Year Budget 2025-2026: Fiscal Budget was presented with no property tax increase, increased fire funding, repaving potentially two streets, tornado siren purchase (partial grant funded), park rail and some beautification. Mayor Edwards made a motioned to approve ordinance with changes discussed in the budget meeting, Seconded by Vice Mayor Pettus. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. Approved 1st Reading 3-0.

Maintenance Expenditures: Mayor Edwards discussed some changes to maintenance bidding and expense tracking to allow for better forecasting of costs for routine repairs from the maintenance contractor.

Bank Services Bid: City Clerk Ms. Bowman presented commissioners with bids from four area banks. Commissioner agreed the current account at United Community offered the best services. Mayor Edwards made a motioned to stay with United Community Bank, Seconded by Vice Mayor Pettus. Roll Call Vote: Commissioner Kirby: Yes, Vice Mayor Pettus: Yes, Mayor Edwards: Yes. Approved 3-0.
